

Revelations about Alan T. Chan

Find Out whom Judge Jane Gallina-Mecca is Protecting and Coddling

As many of you know, Judge Jane Gallina-Mecca rewarded a violent perpetrator she has been protecting, who almost killed both his children by head injury and attempted to murder his ex-wife multiple times, with sole custody of the children, all marital assets, “child support,” all his legal fees, and now the house—even though what he owes me alone is almost twice the full equity of the house. None of this matters—only that the criminal is rewarded in Family Court. This is now a consistent formula for the Family Courts: children are too “valuable” a commodity to keep with the good parent, and so they are stolen and “sold” to the violent offender who is promised all the remaining assets—*especially* the house. Hence, for the next five days, I will make Alan T. Chan a case study for illustrating the kind of violent criminals and dangerously-disordered personalities Family Courts empower and protect. Below is my last attempt to reach my former brother-in-law, but he is not a rational person; he responded with an immediate filing for violent seizure of the house. I warned him that I would publish all the incriminating information about him, so that the public can learn from the hundreds of pages of evidence what atrocities are being permitted through the Family Courts.

Alan,

You *must* realize by now that you were sold a bill of goods by a corrupt court. Continuing as you have been, hoping that one day you will get compensation for all your losses is not more than a pipe dream! Jane Gallina-

Mecca never cared for you, and now that she is becoming infamous throughout the country through my public testimonies, she will be busy protecting herself, not you!

Besides, you are about to become famous yourself: just from my past week of writings (mostly on Gallina-Mecca), there has been: a committee on family court reform that set up a web site for me to publicize about you (alantchan.com); an institute that drafted a press release to go out about you; and a group of journalists that promised to write about you. Also, for Patricia's protection, I have invited more people to stay in the house, so that your "army" will have to go through more layers to try to drive her out.

Above all, the documented injuries you and the court incurred on Patricia alone are not going to allow you to barge in and seize the house this time. The Law is very clear about disabled individuals, and Patricia is pretty severely disabled now, thanks to you. You may get arrested if you try to aggress anymore, and Gallina-Mecca will be seen as the criminal she is outside her fiefdom (numerous legislators from multiple states are now hearing about her, and I can tell you, they are all aghast; we may even take up their offer to initiate calls to the New Jersey legislature, in order to expedite her impeachment).

All this is to say, Jane Gallina-Mecca will not be around for you much longer—and she never was. Don't you see by now that she was leading you on all this time, giving you empty promises? If Patricia, who genuinely loved you, was not willing to be your "mommy", what makes you think that Gallina-Mecca would be? These are issues you needed to work through with a real therapist (not a fellow personality-disordered one).

Ultimately, life is far more fulfilling when you face your problems and truly work on them step by step, instead of looking for fantasy "fixes" that inevitably crash (the maximum-security prisons where I have worked are full

of people who thought they would never be caught, would live “the high life,” were entitled to “everything”, etc.).

You should know by now that depriving your children of their mother, simply because you are jealous of their relationship, is not being responsible. You do not understand that they will never forgive you for what you have done—never. You have a captive audience right now, and they nod their heads and smile in front of you, but capturing and attempting to brainwash children against their mother eventually backfires—especially when the truth comes out about you. There will be a book release and possibly more, as there is a national coalition forming around this case alone. You will not be able to contain the groundswell through legal threats and intimidation alone.

Can we settle this like responsible adults, whose only interest is the true benefit of the children and not our own, disguised as such? Can you not see that your children stopped growing like other children—which is indicative of severe psychological trauma—and are physically deformed as a result of extreme stress? If you have been so deluded, humored, tricked, and deceived that this would benefit you, wouldn't it be helpful at this point to cut your losses?

Patricia's death is not an option. If you try to drive her out of the house before she recovers—then all that you are really doing is exponentially extending her medical need to remain in the house! If she dies, then the house will not be the only thing you lose. You and the court must know that she tried to move once and almost died (she sustained mini-strokes that caused irreparable brain injury and loss of cognitive function, and whole-body muscle contractions that destroyed a knee, so that she would never play tennis again). In this manner, I have reams of documentation that prove beyond a shadow of doubt that you were culpable of murder.

Can you not be more sensible, and discuss this in a rational and mature

manner? You do not know that, in order to have compassion, you have to give compassion. You do not know that, in order to be loved, you need to give love. Waging war against your family for “not respecting you enough” is not a way to gain respect.

I know that you, in your own quiet way, have suffered immeasurably. Indeed, with all that everyone has gone through, you have perhaps suffered the most. This is why you have been in an attack mode for the last five years. This is why violent gangsters such as Evelyn Nissirios and Gallina-Mecca gravitated toward you to cut you a “deal”. But the choices you are making are self-destructive. Gallina-Mecca’s coddling and enabling you is about to come to an end. Nissirios is also encountering obstacles she never knew before. This is perhaps the last chance for you to come to a settlement, before reality implodes and explodes in and around you.

The tragedy is not just Patricia’s and your suffering, but what a child psychiatrist familiar with your case defined as, “soul murder”—of the children. They are alive, but you destroyed their spirit. I encountered countless prisoners who called themselves, “walking tombs”—and every one of them had a parent who deprived them of something they critically needed, as you are doing now. Can you not understand that the vindictive part of you—that you directed against your children, that caused you to feel hatred for Patricia, and the vengeance that you are seeking for the love they have for one another—is not only destroying them, but destroying you?

People get divorced all the time, and when they do, they act like responsible adults and parents. You can do this in a responsible and mature way, or like an angry five-year-old. By doing so responsibly, through negotiating, reconciling, and not letting the court hemorrhage your money away, you will feel something for the first time. By looking beyond your selfish, famished interests, you will realize you will gain a lot more: you will feel love, you will feel connection, and you will feel meaning in your life. This is actually

the secret of life that people who are caught in self-destructive, Darwinian ways do not realize. Stop the vicious circle, and join in the secret.

The question is this: do you want to go through this for the rest of your life, or do you wish to be free? Your current path leads to at least fifteen more years of legal battles, appeals, criminal prosecutions, and more lawsuits (have you noticed that more and more child victims of family courts are suing their abducting fathers?). Or you can choose freedom. All it takes to be free is a gesture of reconciliation, compromise, fairness, and openness to healing.

If not, by the time you can no longer deceive yourself, you will find that, not only did you lose your children for the rest of your life, you will have lost your self-respect, and you will have lost everything. If you continue to use your children as pawns for financial benefit—you will eventually discover that you lost your soul—which means you will have lost the meaning and purpose of life. It should also be clear to you now that pretending moves you further, not closer, to the real, and every human soul longs for and seeks the real.

The greatness that you so desire does not lie in things; it lies in how much you love. I appeal to the capacity for greatness that lies dormant in you, for I know you desperately seek something beyond this. All the time that you thought this court was on your side, they were playing you for a sap. This is why none of this has been fulfilling—and simply planning to lie and steal even more will not fill that void.

If you continue to fight, you will succeed in destroying everyone: Patricia, your children, your father, my father—and ultimately, in the end, you will realize that you have destroyed yourself. Please do the right thing, for yourself if not for your children!

In a compromise, no one gets everything they want, but they settle like adults

and get to keep everything among themselves—not liquidate everything to predatory “court actors,” aiming precisely for weak links in the chain like yours.

I write to you in the name of love. When you were first introduced to our family, my mother treated you as a son, I treated you as a brother, and Patricia treated you as a god. Then everything changed when Patricia became occupied with raising children. Mothers are supposed to raise their children, and what you thought was her ceasing to love you or praise you—was simply Patricia’s responsibly fulfilling her role as a mother for your children! This is what mothers do. If you needed Patricia to devote her life solely to you and to no one else, then you should never have had children.

You do not have to be a psychiatrist to know that children need a mother in their lives. Take a good look at your children; they are not thriving but, frankly, suffering a slow death. I appeal to the Alan we first met and adored. That is the essence of who you really are. Can you not rise to the occasion and do the right thing?

If you want to dialogue about this, then give me a cue, and we will find a way. Even just the word, “yes”, is enough. Write just the word, “yes”, and we will find a way to communicate that will be comfortable for both of us. This will not mean capitulation—it simply means that you are open to dialogue, like ceasefire negotiations in the midst of war. I think you will find it beneficial.
