Because of “clients” like Alan T. Chan, Family Courts have ironically become congregating places for the most violent, psychopathic, and sadistic criminals, both as “litigants” and as co-conspiring “court officers,” in a setting where some of the most powerful members of society (judges) prey upon the most powerless and vulnerable (children). “Children’s” guardian *ad litem*, Evelyn Nissirios, for example, helped Alan T. Chan—who had been on a restraining order for almost killing both his children by head injury and whom six world-renowned forensic experts warned was a danger to his children—to obtain full, sole custody within four months. When Alan T. Chan crossed state borders in an attempt to flee with them, violating court orders after having stolen their passports, Nissirios covered for him. When Patricia Lee retrieved her distressed, suicidal children (from the terror of their attempted abduction) slightly early from school on her assigned weekend, Nissirios and Alan T. Chan did not miss the opportunity to descend on her like hawks! They falsely accused her of “absconding” with them for taking them to a nearby hotel pool to de-stress—which did not violate any court order—and when Patricia Lee requested an adjournment of a hearing with a doctor’s note because of a medical emergency, having visited the emergency room two days prior because of Nissirios’ and Alan T. Chan’s constant harassment through their relentless, hourly messaging—no doubt to interfere with her weekend with her children—Nissirios filed for contempt and orchestrated a police raid, in an apparent attempted murder. This is how a “children’s” guardian *ad litem* arranged for a “SWAT team” of five police officers to rip from a mother’s arms two small screaming, crying children, desperately clinging to her—all for the satisfaction of their “father”, Alan T. Chan.

Since Judge Gallina-Mecca and her court appointee serve as “hired hitwomen” for the violent father, Alan T. Chan, the truth will not be convenient for them (they are, indeed, allergic to evidence—which is why it must be presented here, for the children’s safety). Over the course of the past several weeks, Ms. Patricia Lee's behavior has become increasingly concerning, making allegations that the children are being abused by Father, Alan Chan, therapeutic providers, and the Court, all of which have been determined to be unfounded by ~~the Court~~^{DCPP} to date as it relates to the Father.

Ms. Lee failed to appear at an emergent Court hearing today at 1:30pm. ~~It~~ regarding custody and parenting time. It was determined that Ms. Lee had removed the children from school at approximately 12pm under the guise that they had a medical appointment. Upon speaking with the pediatrician Dr. Wu at North Jersey Pediatrics, no such appointment occurred or existed today. According to the Father, he discovered that the child's Gizmo watch was disengaged at approximately 12:30pm today, disabling contact with the child and location services/tracker. Ms. Lee's attorney was not able to contact Ms. Lee this afternoon as all attempts by the Court and her attorney yielded no response. As a result of Ms. Lee's actions, it was Ordered by Judge Gallina-Mecca that custody be immediately transferred to Father, Alan Chan, pending further Order of the Court and that Father have temporary sole legal and physical custody of the minor children.

I am the Court Appointed Guardian ad Litem for the minor children [REDACTED] Chan and [REDACTED] Chan.

AFFIDAVIT OF PATRICIA J. LEE

I, Patricia J. Lee, duly sworn upon oath, declare the following statement is true to the best of my knowledge:

N.J.S.A. 2C:33-4A, Harassment, through collusion with Alan T. Chan, in instigating a life-threatening medical condition

1. Evelyn F. Nissirios, instead of acting as my children's guardian *ad litem*, has acted more as Alan T. Chan's personal attorney. Call logs indicate daily conversations at times, while I have suffered extreme prejudices due to her not responding to my lawyer or to me on critical matters. Most notably, she played an integral role in instigating life-threatening blood pressure spikes in me, in collusion with Alan T. Chan, during the weeks leading up to my first full weekend with my children, starting on November 12, 2021. While Alan T. Chan harassed me with constant text messages, Evelyn F. Nissirios simultaneously harassed me with constant, demanding messages regarding detailed reports on the children's activities, schedules, and plans, as she had never done for Alan T. Chan. These actions together caused me to land in the emergency room on November 10, 2021 (see **Exhibit 1**, which is one of six [6] related emergency room visits). Then, on November 12, 2021, upon learning that I was suffering from a medical emergency, she orchestrated a police raid, together with Alan T. Chan, by lying to the police.

2. The deliberate intent of Evelyn F. Nissirios in lying to law enforcement regarding her belief that I was "absconding" with my children on a weekend she herself assigned for me to have them is apparent from the fact that she said nothing about Alan T. Chan's *actual* attempt to abscond on November 5, 2021. Alan T. Chan's stealing my children's passports and crossing state lines, *explicitly in violation* of Court instructions, did not bother Evelyn F. Nissirios – even though he was recently on a temporary restraining order (TRO) for causing both his children serious head injuries. Then, on November 12, 2021, on my legitimate weekend with my children, as she herself assigned (see **Exhibit 2**), she filed a false police report against me, supporting Alan T. Chan's accusation that I was "absconding". Evelyn F. Nissirios herself had assigned this weekend for me to be with my children, but she told the following lies and ambiguous statements in an egregious attempt to mislead the police, which resulted in the police falsely seizing my children (see **Exhibit 3**). Here are her lies:
 - a. She stated that she "was concerned for the welfare of the children," but there was never a question about the welfare of my children under my care, as I raised them not only successfully but thrivingly with perfect emotional and physical health, since the moment of their birth, for the first ten years of their lives. Alan T. Chan, on the other hand, was just a few months out of a TRO for potentially lethally injuring both children and gradually recovering his custody time from zero (0).

- b. She knew that this was my weekend with them, since she assigned it to me, as stated above. I took them to a hotel within New Jersey, about twenty (20) minutes away, which was well within Court directives, but she turned this into “absconding”.
- c. She also reported that all attempts to contact me “by the Court and [my] own attorney were unsuccessful,” when just earlier in the day she received a doctor’s note notifying her of my medical emergency and that my sister, Dr. Bandy Lee, was to be the contact person for all communications until my recovery. Additionally, she was partly the cause of this medical emergency, as I almost died from high blood pressure two (2) days earlier, as a result of her constant harassment, in apparent coordination with Alan T. Chan, as described above.
- d. She buttressed Alan T. Chan’s lie to the police that I was a “high risk parent due to psychological issues,” when she, above all, should know that no such evaluation was made (she would later suppress nine [9] psychiatric evaluations by high-credentialed experts reporting that I have “excellent mental health” and “exceptional talent in parenting”). She also suppressed Alan T. Chan’s diagnosis of *psychopathy* by two highly-qualified forensic psychiatrists – which was later confirmed by four (4) additional experts who declared him a *danger* to my children.
- e. Most egregiously, she held an *ex-parte* hearing without notifying me or my attorney, as required by the law, which resulted in the “civil orders indicating that Mrs. Patricia Lee’s parenting time and custody of the children is suspended” – but she conveniently omitted that I had not yet received this order, that no one had ever gave me any warning of such suspension, and until that secret meeting my conduct with the Court was exemplary and without a single error. The order itself gave no explanation for my loss of custody, no evidentiary hearing was held for two and a half (2 1/2) years, and Evelyn F. Nissirios has needed to barrage the Court with lies – more than three hundred fifty (350) of them – in order to keep this obviously illegitimate arrangement.
- f. In a written statement, she lied that: “Over the course of the past several weeks, Ms. Patricia Lee’s behavior has become increasingly concerning, making allegations that the children are being abused by Father, Alan Chan.” This was a lie, since I never made any “allegations”. What Evelyn F. Nissirios received were objective evidence and medical reports of the children’s injuries, including photographs of cuts, bruises, bloody shirts, a suicide note, and the children’s own written letter to the Court asking that she recuse herself (my children, being prodigies, composed this on their own). Police escort was also necessary when the children refused to go to their father and on one occasion attempted to set the house on fire, because going to “that maniac” (their father) was “torture” and “worse than death.” Ms. Nissirios suppressed all this evidence and stifled the voices of the children she was supposed to represent.
- g. She also lied that I complained about: “therapeutic providers, and the Court, all of which have been determined to be unfounded” – when in fact it was not I but my sister, Dr. Bandy Lee, who is a world expert on child abuse and coauthor of the United Nations Secretary-General’s chapter on “Violence against Children,” who reported the Court-mandated therapist for abusing my children, and indeed her licensing board investigated and adjudged her to be guilty and removed her from the case. DCPD, under Court instruction, refused to interview my sister, even though she was an adult living in the household and a witness of Alan T. Chan’s daily abuse of my children for fifteen (15) months. Furthermore, three (3) highly-credentialed psychiatrists evaluated that, based on documentation of their medical decline, my

- children were “traumatized”, under “alarming” circumstances, and “tortured” by Alan T. Chan and Evelyn F. Nissirios – all of which Evelyn F. Nissirios again suppressed.
- h. She lied that: “Ms. Lee failed to appear at an emergent Court hearing today at 1:30 p.m. regarding custody and parenting time.” A doctor’s note of a medical emergency was submitted with a request for adjournment, which is not simply “failing to appear.” Also, I was never notified that my custody and parenting time were in question, when the only person whose custody was in question was Alan T. Chan.
 - i. She lied that: “Ms. Lee had removed the children from school ... under the guise that they had a medical appointment.” Alan T. Chan knew I had an appointment, and both knew I would need to take them immediately after the Court hearing, which was why I took them out of school in time for the Court hearing – until my sister, a physician, pointed out that emergency room instructions from two (2) days ago were to avoid stress for the next few days.
 - j. She lied that: “As a result of Ms. Lee’s actions, it was ordered ... that custody be immediately transferred to Father, Alan Chan.” My actions were legal and legitimate. It was as a result of whatever Evelyn F. Nissirios told the judge, in a secret meeting that illegally precluded me, that custody was immediately and permanently transferred.
3. This false police report, together with Alan T. Chan’s false police report, resulted in manipulating the police to raid and seize my screaming children at the onset of my weekend with them, and became the basis for my not seeing or speaking to my children to this day, and my children being separated from the only parent who raised them, and the only nurturing home they have known, all their lives – not to mention all the adults who love them – to be trapped with a man they used to call, “the scariest person,” and begged my sister or father: “Please don’t leave me alone with that maniac!”

- 4. Evelyn F. Nissirios is guilty of lying and perjuring almost three hundred fifty (350) documented times (see **Exhibit 4**) in official proceedings, while affirming the truth of her statements, despite knowing them to be untrue.
- 5. Evelyn F. Nissirios has also suppressed numerous pieces of evidence, regardless of their meeting the highest standards of admissibility under rules of evidence. This action has been decisive in affecting the outcome of the proceeding, as well as the disposition of my children. There is substantial evidence that she believed the falsification to be critical.
