I heard of three mothers committing suicide in just the past two weeks, after Family Courts seized their children. What we hear even less about is how many children are taking their lives when they are seized from their loving, well-bonded, primary parent, to be forcibly given to their abuser, batterer, rapist, or murderer. This is what Family Courts do to 100,000 children per year, as its 175-billion-dollar industry is predicated on breaking humanity's most basic, parent-child bond. For what? For the “satisfaction” of someone like Alan T. Chan, who needed to punish his prodigy children for having a mind of their own! When they created a “children’s constitution” for their “emancipation”, Family Court stifled their voices for him. When they kicked, screamed, cried, and tried to commit suicide for having to visit him, Family Court coerced them. When the children locked themselves in their rooms, refusing to go to him, Family Court made the police escort them (which gave him the ammunition to threaten them with “arrests” if they did not obey). When his 7-year-old returned to needing diapers from his abuse, he chastised him so badly, the child stopped wearing diapers but would henceforth only sleep on the floor. When the emergency room doctor saw them after a suicide attempt and arranged follow-up with a psychiatrist, the Family Court-appointed guardian *ad litem* (their “lawyer”) intercepted and canceled the appointment. When the pediatrician identified child abuse and recommended a psychiatrist, Family Court silenced her and mandated that they only see (non-psychiatrist) “Barbra”, who locked them in her office if they refused her “therapy”, after which they were even more suicidal (she was later investigated and removed by her licensing board). Still, all this was mild compared to what was to come.

Since Judge Gallina-Mecca’s courtroom shuns evidence and truth—and considers its “task” to serve the psychopath of the family—the damning evidentiary material will be exhibited here. Below is the children’s letter to Judge Gallina-Mecca, as well as a suicide note that was found, following Alan T. Chan’s attempt to abscond with them (when he was caught in Pennsylvania with their passports). Below is my children's letter to the court asking it to fire their "lawyer" (guardian *ad litem*) and "Barbra" (their "therapist" Ms. Barbara Maurer, whom Atty. Nissirios forced them to return to, even after she was witnessed to be abusing them).

Nov 8, 2021

To Court

Dear Court,

I am highly disappointed in your decisions and they are **VERY** foolish. Without the approval of my brother and I, it will not pass, for we can refuse and decide our own choices. Right now I will refuse our lawyer, who shall remain nameless. Along with Barbra for both of them are no help.

In the own words of my brother, [redacted] "Your decisions are so **DUMB** that it is as dumb as eating a banana with ketchup!" If you don't believe these are his own words, I have his signature [redacted].

One thing I would edit is...

- Be home for Mom's birthday
- Be as equal as adults
- Live in the way I want to live

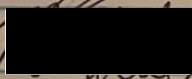
And change my lawyer because she is being my enemy.
I demand my mother have a equal voice as my father.

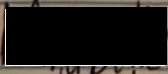
My demands...

I wrote this letter with my own hand,

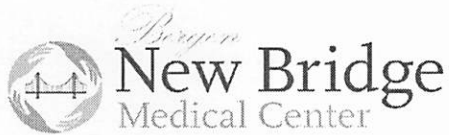

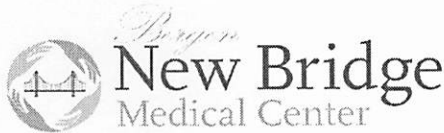
History of present illness:

Patient is a 9-year-old female with no prior psychiatric diagnosis, however receiving therapy weekly since March of this year. Patient reportedly has been mentioning suicide over the last 8 months, has been noted to have screaming spells, chewing on stuffed animal, and "dissociating". Patient reportedly has crying spells, goes into her room and comes back out with a smile. Recent psychosocial stressors include the separation of her parents, to which the patient and her younger sibling were made aware on April 30th of this year. Out of concern patient's mother brought her to Bergen new Bridge Medical Center along with her younger brother for psychiatric evaluation, and desire for outpatient psychiatric care. Of note patient's mother states that she has been unable to secure outpatient appointment with a psychiatrist until October or November of this year.

Upon evaluation patient is noted to be calm and cooperative. Patient denies depressive symptomatology of low mood, poor concentration, increased guilt, low energy, or suicidality. Patient however endorses irritability, and trouble sleeping over the last few months. No symptoms of anxiety, mania, or psychosis reported or elicited. Patient denies suicidal ideations, intent or plan. Patient denies homicidal ideations, intent or plan. Patient denies auditory/visual hallucinations.

HPI

History of present illness:

This is a 7 year old Asian American boy with no past psychiatric history who was brought in by mother for 4 months of behavioral regression in the context of his parent's ongoing divorce. Mother informs that on 4/30/21 she informed her children about impending separation from their biological father. Since this time, patient has been emotionally labile, behaviorally acting out, and increasingly defiant towards instruction. She also informs the patient has been caught masturbating excessively on multiple occasions and endorses increasing episodes of nocturia, daytime urinary and fecal incontinence, as well as thumb-sucking. Mother states that patient now requires wearing a diaper despite previously being toilet trained. On day of evaluation, mother informs patient experienced "an emotional breakdown" while talking about starting school on 9/1/21 and was subsequently brought to the BNBMC ED for psychiatric evaluation.

In the ED, patient presents friendly, cheerful, and cooperative towards assessment. He denies the presence of any mood or anxious symptoms and states he's looking forward to beginning school so he may see his friends again. He denies any SI or HI with intent or plan and denies ongoing AVH.

Comments: No history of illicit substance use.
